



The key information you need for your stay in Romania











Here is a brief guide on your fundamental rights and other helpful information while you stay in Romania.

Fundamental rights you should know about:

You have the right to seek asylum

Asylum applications are submitted in person by foreigners located in Romania or at a checkpoint for crossing the state border. For minors under 14, applications can be submitted only by an adult, their legal representative. The authorities may not refuse the asylum application because it was submitted late.

If you are an unaccompanied minor who seeks asylum, llocal social services will assign you an adult as a legal representative to assist you during the entire procedure. You have the right to be safe: If you feel in danger or need help, call 112 or 119 immediately (a unique line dedicated to children)!



Fundamental rights you should know about:

You have the right to work on the Romanian market without the need for a work permit

You can get a job based only on a written personal declaration where you assume to meet the necessary skills and experience for the job.

• If you have a remote job or a company registered in a country outside Romania, you can request a "digital nomad visa". This will allow you to get a resident permit for 12 months while working remotely.



Rights for children:

All the Ukrainian children who entered Romania's territory, including those who do not apply for asylum, have the right to:

- Be integrated into Romanian schools or kindergartens, free accommodation in boarding schools, food allowance, footwear, clothing, school supplies under the same conditions as Romanian children;
- Free access to all the public transport (busses, trains, subway) and free meals for all the students in primary and gymnasium level.



All Ukrainian citizens have the right to study for free in Romanian universities until 2023 under the following conditions:

- After your personal request and with the consent of the university;
- You can be admitted without proven documents on your level of studies and provide your last degrees until the end of the cycle of your studies;
- Enrollment can be done in all 3 cycles of studies bachelor, master, and doctorate.



For people with disabilities and the elderly:

If you are a person with disabilities, you have the right to benefit, upon request, from social services:

- sheltered housing,
- assisted care,
- access to training centers for independent living, or rehabilitation centers.

If you are an older person, you have the right, on request, to access social services under the legislation on social assistance for the elderly.



For families with children

Ensure that your child is protected against dangerous diseases. Get all the recommended vaccines, including against polio and measles. Check with the County Health Authorities or visit any local clinic to ask about the recommended vaccines in Romania and how to get an appointment.

According to the national law, if you have children, you can request integration into daycare centers or benefit from counseling centers and other social benefits.

No matter your situation, you can ask local authorities for information, social workers, NGO staff and volunteers.



For language barriers:

You can use mobile apps for automatic translation. You can use these apps even for live conversations or take photos of any text, and it will translate right away.

Other suggestions:

- Try to keep a daily routine for children. If you can, make them a schedule for playing and learning activities. It will help him mentally but also emotionally;
 - Don't leave your children unsupervised;
- Journalists, NGOs, and any other citizens are not allowed to interview/photograph your child without your recorded consent;
- Exchange cash only at banks and other authorized currency exchange offices;
- Identity documents should be handed only to government officials.
